The rates for the distribution of parcels from non-EU shipments are calculated by combining the following two elements per offer:

1. To multiply the total number of parcels per destination by the rate per parcel for that destination.
2. The actual weight or the calculated weight, where the higher of these two weights applies.

This (actual or calculated) weight per parcel is multiplied by the rate per kilogram for that destination.

The calculated weight is determined by the formula: length (cm) x height (cm) x width (cm) / 6000
